Contributors

Andreas Benz is a research associate at the Centre for Development Studies (ZELF), Freie Universität Berlin, in the BMBF-funded competence network “*Crossroads Asia: Conflict, Migration, Development*”. His research focuses on education and migration in the context of rural development and socio-economic change with a particular interest in the role of social networks and translocal processes and relations. He is the author of the book ‘Education for Development in Northern Pakistan. Opportunities and Constraints for Rural Households’ (Oxford University Press: Karachi, 2014).

Simone Christ received a M.A. (Magister Artium) in Sociology, Cultural Anthropology and Political Science at the University of Trier in 2008. Since 2008, she works as a lecturer at the Department of Southeast Asian Studies at the Institute of Oriental and Asian Studies at the University of Bonn. Her PhD project focuses on the Philippine culture of migration. Her research interests include the anthropology of migration, international labor migration, anthropology of development and sociology of the family. Her regional focus is on the Philippines.

Stephan Conermann was born in 1964 in Kiel, Germany. He is Professor of Islamic Studies at the University of Bonn since 2003. He has served as Vice Dean of Research and International Relations of the Faculty of Humanities at the University of Bonn (2008-2010) and has been a speaker for the Bonn Asia Center (since 2008), the Bonn Center for Transcultural Narratology (BZTN, since 2009) and the Bonn International Graduate School of Oriental and Asian Studies (BIGS-OAS, since 2010). He studied Ancient, Early Modern, Modern and Asian History as well as Slavic and Oriental Philology at the University of Kiel. In parallel to his studies, he took multiple language courses and completed study visits in Beirut, Damascus, Moscow, and Poznan. He did his doctoral studies at the Department of Oriental Studies at Kiel University from 1992 till 1996 and then worked as Research Assistant and Assistant Professor at the university until 2003. Amongst his recent publications are “Das Mogulreich. Geschichte und Kultur des muslimischen Indien“ (Munich, 2006), “Mamlukica – Studies on the History and Society during the Mamluk Era/Studien zu Geschichte und Gesellschaft der Mamlukenzeit“ (Göttingen,

2013), “the edited *Ubi sumus? Quo vademus? Mamluk Studies – State of the Art*” (Göttingen, 2013), “Narrative Pattern and Genre in Hagiographic Life Writing: Comparative Perspectives from Asia to Europe” (Berlin 2014, edited with Jim Rheingans), and the edited “History and Society during the Mamluk Period” (1250–1517), “Studies of the Annemarie Schimmel-Kolleg I” (Göttingen, 2014).

Jeanine Dağyeli studied Central Asian and Islamic Studies at the Humboldt University, Berlin, from where she received her PhD on the Central Asian crafts’ codices (*risala*) in 2008. Currently, she is a research fellow at Zentrum Moderner Orient, Berlin. Her research interests include historical and economic anthropology of Central Asia, death-related beliefs and practices, folk medicine and popular literary genres.

Anna Grieser holds an M.A. degree in Social and Cultural Anthropology and is a doctoral candidate at the Institute of Social and Cultural Anthropology, Ludwig-Maximilians-University, Munich.
